
YANCEY COUNTY DAY OF PRAYER PROCLAMATION


Adjournment

WHEREAS, the COVID-19 virus has affected our land physically, mentally, spiritually and economically. Our land and people need a divine touch from an almighty God; and

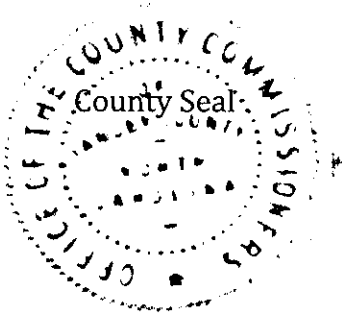


